Itemization of Polling Places/Precincts Not Balanced

ADMIRAL CONGREGATIONAL CHURCH	-1	Assume unidentified voter did not cast ballot. Ballots handcounted. Called inspector; not able to provide additional information.
BEACON TOWER	1	One additional voter credited. Could not resolve.
BELL TOWER	1	Ballot issued and cast by unidentified voter. Voter not listed on inspector's list nor signed in poll book. Hand count of ballots confirms election day poll count.
BELL TOWER	-1	One unidentified voter did not cast ballot. Inspector could not explain.
BROADMOOR CLUB	1	AVU ballot not properly spoiled. Voter 760122386 also voted paper ballot.
BRYANT ELEMENTARY	-1	One unidentified voter did not cast ballot. Inspector could not explain.
CENTRAL LUTHERAN CHURCH	-1	One unidentified voter did not cast ballot. Inspector and judge could not explain.
CENTRAL LUTHERAN CHURCH	-1	One unidentified voter did not cast ballot. Inspector and judge could not explain.
CHURCH ON THE RIDGE	-1	One ballot which was spoiled may have been an abandoned ballot. Voter unknown., thus one voter credited who did not cast ballot.
EMMANUEL BIBLE CHURCH	1	Per Inspector, voter was given two ballots that were stuck together, voted the front of one and the back of the second and inserted both into the AccuVote.
FREMONT BAPTIST CHURCH	-1	Unknown voter abandoned ballot. In spoiled ballot bag marked "abandoned."
HARVARD COURT	-1	Per incident report and phone call to judge, one voter destroyed ballot and left polling place with it. Cannot identify voter.
HOPE LUTHERAN CHURCH	-1	One ballot issued not cast; unknown voter. Inspector and judge contacted. Could not resolve.
JEFFERSON HIGH SCHOOL	1	AVU judge did not correctly spoil AVU ballot for voter 940271096. Voter also issued paper ballot.
KING COUNTY FAIRGROUNDS MAIN OFFICE	-1	Per Inspector, one unidentified AVU voter did not cast vote; unknown which voter.
OLYMPIC VIEW COMMUNITY CHURCH	3	Due to unknown. Could not resolve.
OLYMPIC VIEW COMMUNITY CHURCH	3	Due to unknown. Could not resolve.
MAR VISTA SCHOOL	-1	One ballot "abandoned" by unidentified voter. Ballot sent to canvass board for determination.
MEAD ELEMENTARY SCHOOL	-1	Per Inspector, voter walked out without casting ballot. Doesn't know which voter.
MEANY MIDDLE SCHOOL	1	Per AVU judge, voter cast ballot without votes (blank) on the AVU. Then voter was reissued a card to vote again.
NORTH HILL COMMUNITY CLUB	-1	Appears voter 920241611 after spoiling paper ballot did not properly cast AVU ballot.
SACRED HEART CHURCH VESTIBULE	-1	Inspector indicated ballot left on AccuVote was put in base unit then at close of polls ripped in half and placed in the unused ballot bag. Ballot could not be retrieved prior to certification.

SEALTH HIGH SCHOOL	Net -1	Appears AVU voter did not properly cast ballot.
SEATAC BIBLE CHURCH	-1	One voter with ballot # issued out of order and name appears to have line thru it, however, inspector could not explain. Not enough information to remove credit.
SEATTLE CENTRAL COMMUNITY COLLEGE BROADW	1	Suspect poll ballot issued to provisional voter was put thru AccuVote.
SEATTLE CENTRAL COMMUNITY COLLEGE BROADW	1	Suspect poll ballot issued to provisional voter was put thru AccuVote.

SHORELINE UNITED METHODIST CHURCH	1	Inspector stated that blank ballot was cast by mistake as trouble shooter was fixing AVU.
SHOREWOOD SCHOOL	1	Per Inspector, they did a blank "test" ballot to show how to work the AVU.
SOMERSET SCHOOL	1	Per inspector, AVU judge cast "test" ballot
STEWART MANOR	1	AVU judge did not correctly spoil AVU ballot for voter 840727491. Voter also issued paper ballot.
SUNSET ELEMENTARY	1	One additional voter credited. Could not resolve.
SUNSET HILL COMMUNITY CLUB	-1	One additional voter credited. Voter #10018374 name crossed out on Inspector list but not on poll book. No spoiled ballot.
THE JOSEPHINUM	1	Inspector noted in poll book that he gave voter 921379633 a paper ballot after voter had already cast his AVU ballot.
TIMBERLAKE CHRISTIAN FELLOWSHIP	-1	One "abandoned" ballot found by inspector on floor near AccuVote and placed in spoiled bag. Voter not identified. Assume was rejected from AccuVote and not recast.
TUKWILA ELEMENTARY	Net +1	AVU not properly cancelled.
YESLER TERRACE COMMUNITY CENTER	4	4 voters issued regular ballots rather than provisionals.
YESLER TERRACE COMMUNITY CENTER	1	1 voter issued regular ballot rather than provisional.
