RE: 2005 General Canvass

Attached are the results of the 2005 General canvass. Of the 2,519 polling place precincts involved in the 2005 General, there were 34 precincts that did not balance to zero which represents 1.3%. Of the 34 precincts that did not balance to zero, we were able to account for the variance of -1 or -2 in all but 19. The 34 precincts are outlined below:
